

Avalon Wolves Pop Warner Parent Code of Conduct

I hereby pledge to provide positive support, care and encouragement for my child participating in the Avalon Wolves organization by following this Parent's Code of Conduct Pledge:

- I will encourage good sportsmanship by demonstrating positive support for all participants, coaches, officials and Board Members at any League or Pop Warner sanctioned event.
- I will demand a drug free and alcohol free environment for my child at all League sponsored events.
- I understand that the Avalon Wolves Program is for the children and not adults. I will not use the Wolves as a babysitting service and will supervise my child in the program and any other children I bring to an event.
- I will do my best to make this a fun organization for my child.
- I will ask my child to treat other participants, coaches, Board Members, parents, and spectators with respect regardless of race, sex, creed or ability.
- I will, along with any guest of mine, refrain from any vulgar, lewd, obscene language or gestures while participating or watching any League, Regional, or National Pop Warner sponsored event.
- I will strive to be a good role model for my child and the other children in the program. I will encourage my child to learn "losing with dignity and winning with grace."
- I will direct my comments and criticisms of parents, participants, coaches, officials and Board Members away from the children participating in the League and conduct myself in a calm and civilized manner.
- I will not use social media in any form to criticize or belittle the League, other participants, coaches, officials or Board Members.
- I will not disrupt practice or game time to address an issue. I will follow the proper chain of command and wait for an appropriate time.
- I understand and will follow the proper chain of command: Team Parent-Head Coach-Association Football/Cheer Director-Commissioner. I know that I must follow this chain of command for all communications.
- After August 1st (or first practice of the season-including spring season), I understand there are no refunds of any amount allowed. If I choose to leave the program after that, before the end of the season, I will return all loaned equipment within a one week period.
- I will respect my child's coaches and do my best to have my child at all practices and events on time.
- I understand it is my responsibility to utilize team/association communications in order to be fully aware of any obligations, events, and/or changes in schedule.
- I will ensure my child(ren) is picked up by a responsible adult within 15 minutes of practice end time and will communicate any last minute changes to the team parent and head coach.
- I will respect the authority of my child's coaches, and will not undermine their decision making or thought processes.
- I understand, and agree to abide by the concussion protocol on the football side. On the cheer side, if there is a suspected concussion by a coach, or a parent gives notification of a suspected concussion, I understand that a medical doctor's full release will be needed in order for my child to return to cheer.
- I understand that two weeks prior to any post season/bowl game, exhibition, and/or competition is mandatory practice time unless prior arrangements have been made and documented with the head coach's approval.
- I will never loudly reprimand or physically harm my child after a practice or other event.
- I recognize that the Avalon Wolves Program will only be as successful as its volunteer base and will volunteer to assist whenever possible. At a minimum, my family will volunteer 10 hours.

Failure to abide by this Parent Code of Conduct will automatically render a written warning (via email/text) to the parent and possible removal of their child(ren) from the Avalon Wolves Program. The Avalon Wolves Board Members have the sole right to enforce violations.

Failure to abide by this Participant Code of Conduct will automatically render a child unable to participate in or attend a League, Regional, or National Pop Warner sponsored event. The Avalon Wolves Board Members have the sole right to enforce violations.
